**FOR ENGAGEMENT OF EX-SERVICEMEN ON CONTRACTUAL BASIS**

Government has accorded approval for engagement of Ex-servicemen for 1950 posts of Constables in CRPF on contractual basis for a period of 05 year extendable to 07 years. The selection process will be carried out at following Group Centres, CRPF as per the tentative programme mentioned against each recruitment centre:

2. There is no restriction of domiciliary status for recruitment of above posts.
3. The recruitment is on All India Basis.

4. The eligibility conditions for engagement of Ex-Servicemen on contractual basis to the post of Constable are as under:-

Corps/ Regiment	Infantry, Mech Infantry, Armoured Corps, Artillery, Engineers, Intelligence Corps, Dog squad (ASC), ASC drivers. <b>(Note- Clerks of any Arm are not eligible)</b>
Other requirements	(a) Individual should preferably have done Weapons, Ghatak, CIJW, PC, Junior Leader, IED/ Bomb Disposal course. Served in C.I. areas. (b) Been an Instructor at any school of instructions.

5. The Ex-Servicemen engaged on contractual basis for the post of Constable will be paid the salary as under:-

6. The terms and conditions for such engagement would be as under:-

- i) The Engagement of Ex-Servicemen will be subject to the Medical Examination and verification of his character and antecedents from the appropriate authority as designated for such purpose.
- ii) The contractual appointee during the continuance of term of contract shall be subject to the standard of discipline of the Force and he will execute all the administrative orders either written or verbal passed by any superior officer so designated followed by maintaining Force decorum.
- iii) In case the contractual appointee is found responsible for any act of omission or commission in regard to any indiscipline, they will be treated as likewise CRPF employees and CRPF Act and Rules will be applicable.
- iv) The CRPF during the continuance of this contract shall be empowered to place the contractual appointee in any part of the country.
- v) The remunerations due to such appointee shall be paid till the date he actually worked and such pending dues shall be sent to the appointee through registered post.
- vi) The person so engaged shall have no legal claim to regular absorption after the period of contract expires.
- vii) The contractual appointee shall be allowed to dine in the CRPF Mess and be provided Messing facility at par with other regular employees of CRPF holding similar rank and status on payment system.
- viii) The Ex-Servicemen engaged on contractual basis shall wear the uniform as worn by any regular employee in CRPF followed by maintaining exemplary turn out. The cost of the uniform shall be borne by the Department.
- ix) The Ex-Servicemen so engaged shall discharge their duties as assigned to them from time to time.

- x) Both contracting parties would be free to disengage by serving one month's notice or one month's pay till completion of one year.
- xi) If the contractual appointee fails to deliver in terms of quality and quantity of the norm of duty specified, his services can be terminated by giving one month's notice.
- xii) Medical facilities will be extended at par with CRPF employees.
- xiii) Other allowances like TA/DA, Ration money/free ration, LTC/Railway Warrant, family accommodation, House Rent Allowance etc shall not be admissible. However, to compensate ration Money and washing allowance a fixed allowance of \*Rs.1204/- will be paid i.e Rs.1144/- (Ration Money) +Rs.60/- Washing Allowance = Rs. 1204/- which may change from time to time as per Central Govt. directions.
- xiv) They shall be entitled for 30 days E/L and 10 days CL during the period of contract for one year and also the holidays declared by the Govt. of India by the notification in the Gazette.

7. **SELECTION PROCESS**

- i) No application is required to be submitted in this regard. The recruitment shall be on open rally system. Willing/eligible candidates should appear before the Recruitment Board on the dates prescribed above.
- ii) A detailed Board of officers under the chairmanship of a DIG will check all the documents and put up their recommendation for suitability of the candidate for above contractual engagement.

8. **GENERAL INSTRUCTIONS**

- i) Candidates will have to appear for selection/test at their own expenses and no TA/DA will be admissible. They will also have to make their own arrangements for stay during recruitment.
- ii) No prior application is required to be submitted in this regard. Willing/eligible candidates should appear before the Recruitment Board at one of the above centres.
