Suitable and willing male and female candidates may **WALK IN FOR INTERVIEW** on 28/04/2017 at 0900 Hrs for the post of Clinical Psychologist on contractual basis in CRPF Hospital for one year or till attaining the age of 65 years, whichever is earlier and no extension will be granted.

**Eligibility Conditions/educational qualification:-**

- A) Essential:** - Master's degree in Clinical Psychology of a recognized University or equivalent.
- B) Desirable:-** Post-graduate diploma in rehabilitation Psychology/Guidance Psychology or diploma in Medical and Social Psychology.
- C) Experience:** 3 Years experience in Clinical and rehabilitation psychological setups.
- D) Age :-** Below 65 years as on date of Walk-in-interview.

**Working Hours:-** As per schedule of CRPF Hospitals.

While appearing for Walk-in-Interview, the candidates should bring documents in original & photocopies of all relevant documents (Degree, Age Proof & Experience Certificate etc.), application in plain paper superscripting the name of post applied for & five passport size recent photographs. Interview will be followed by Medical Examination.

## CHARTER OF DUTIES

- a) To screen out CRPF personnel for the engagement in various VIP duties like Parliament Duty Group, Special Duty Group, UN Mission etc.
- b) Assessing force personnel need abilities or behavior using a variety of methods, including psychometric tests, interviews and direct observation of behavior.
- c) Working as part of a multidisciplinary team alongside doctors, nurses and physiotherapist etc for the management of Psychiatry patients.
- d) Devising and monitoring appropriate treatment programmes including therapy, counseling or advice to the patient having psychological disorders or who need psychological support.
- e) Offering therapy and treatments for difficulties relating to mental health issues such as anxiety, depression, addiction, social and interpersonal problems and challenging behavior.
- f) Providing consultation to all ranks of CRPF, encouraging a psychological approach in their work.
- g) Counseling and supporting careers.
- h) Psychological training and personality grooming of personnel for behavior in public.
- i) Any other duties as assigned by IG/Director(Medical) or IG(Medical)/DIG(Medical)/CMO-I/C of the hospital.

## Terms & Conditions

- i) Appointment/Engagement is purely on contract basis and the initial period of appointment of contractual will be for one year or till attaining the age of 65 years, whichever is earlier and no extension will be granted.
- ii) The remuneration Rs. 35,000/- payable to the clinical psychologist, fixed by the Board for the whole tenure of contract and no dearness allowance and other allowance as are admissible to the Government servants shall be admissible.
- iii) The contractual Clinical Psychologist is allowed to join the Force and be continued subject to verification of their character & antecedents.

- iv) The contractual Psychologist may be allowed to join the Force only if they are found fit in the medical examination.
- v) Contractual appointment can be terminated forthwith without paying one month's salary to the concerned in lieu of one month's notice in case selected candidates does not join duty in spite of repeated call up notices. In case to join service within 07 days, the appointment will be cancelled immediately without giving any notice or paying one month's salary in lieu of the notice.
- vi) The appointee shall not be entitled to any benefits like provident fund, pension, gratuity, medical attendance treatment, seniority, promotion etc or any other benefits available to the Government servant appointed on regular basis.
- vii) The appointee will not be granted any claim or right to regular appointment to any post under CRPF.
- viii) The working hours of the appointee as per the schedule of CRPF Hospitals/Establishment or as fixed by competent authority.
- ix) The appointment carries with it the liability to serve in any part of the country.
- x) The appointee shall perform the duties assigned to him. The competent authority reserve the right to assign any duty as and when required No extra/additional allowance will be admissible in case of such assignment.
- xi) On appointment, the appointee will required to take an oath of allegiance to the constitution of India or make a solemn affirmation to that effect.
- xii) If any declaration given or information furnished by him/her proves to be false or if he/she is found to have willfully suppressed any material information, he/she will be liable to termination and also such other action as the Government may deem necessary.
- xiii) The leave entitlement of the appointee shall be governed as per DoP&T O.M. NO. 12016/3/87-Estt(L) dated 12<sup>th</sup> April 1985, O.M. NO. 12016/1/90-Estt(L) dated 05/07/1990 and OM NO. 12016/2/99-Estt(L) dated 12<sup>th</sup> July 1999 and amended from time to time.
- xiv) The retiring or retired Psychologist may be appointed provided that he shall not continue in the post once he reaches the age of 65 years.
