5. As the bids are to be submitted online and required to be encrypted (by their user public-key) and digitally signed, the bidders are advised to obtain Digital Signature Certificate (DSC) from suitable vendor or from any authorized agency at the earliest.

7. Since the procedure is on line, the following documents are required to be Scanned and uploaded on line in CPP portal.

  - (iii) Scanned copy of Registration documents.
  - (iv) Scanned copy of latest Income Tax Return.
  - (v) Scanned copy of Bid security in the shape of latest National Saving Certificate, Bank Guarantee or Fixed Deposit duly pledged in favour of Commandant-166 Bn CRPF, New PCR Camp, Sidhra, Jammu (J&K).
  - (vi) Scanned Copy of valid Registration/License certificate for importing of Raw material, Bottling, Production and Sale of Liquor across India .
  - (vii) Financial Stability Certificate up to the estimated amount of supply of concerned Unit(s) as mentioned at para-I above, from Nationalized /Recognized Banks
  - (viii) Scanned copy of Lab Test Report not older than one year of the product being offered in this tender from Govt. approved Lab .
  - (ix) Scanned copy of Tender documents (Tender Form) duly completed and signed but without indicating the rates quoted.

8. The tender of the firms who fail to fulfill the eligibility information will be summarily rejected.
9. The firms will submit the original document in respect of Bid Money/ Earnest Money deposit details, Bank guarantee and other relevant documents etc. in the office of Commandant 166 Bn CRPF, New PCR Camp, Sidhra, Jammu (J&K) on 07/07/2018 at 1700 hrs.
10. Instructions for e-tendering:-
  - i) Only e. offers submitted online through e-procurement portal will be considered.
  - ii) The bidders should keep checking the website for any addendum / corrigendum to the Notice/ Bidding documents till the date of online submission of bids and the bidder should incorporate the same in his bid documents.
  - iii) Conditional Bids and the bids not meeting the qualifying criteria on the date of receipt of bids shall be summarily rejected.
  - iv) The bidders have to submit their bids online in electronic format with Digital Signature.
  - v) The bids proposed without digital signature will not be accepted. No proposal will be accepted in physical form.
  - vi) Bids will be opened online as per time schedule mentioned in table at para-06.
  - vii) Before submission of online bids, bidders must ensure that scanned copy of all the necessary documents have been attached with bid.
  - viii) The department will not be responsible for delay in online submission due to any reasons.
  - ix) All the required information for bid must be filled and submitted online.
  - x) Bidders should get ready with the scanned copies of tender documents, EMD & other documents as specified in the tender documents.
  - xi) The details of tender documents, EMD specified in the tender documents should be the same as submitted online (Scanned Copies) otherwise tender will summarily be rejected.
  - xii) The firm should register itself on website <http://eprocure.gov.in/eprocure/app> and obtain user ID, password before bid.
  - xiii) Entire tender process will be carried out online through above mention website.
  - xiv) Firms are advised to procure e.token/ Digital Signing Certificate from suitable vendors or from any authorized agency.
  - xv) Before submission of online Bids, Bidders must ensure that scanned copies of all necessary documents have been uploaded with the bid.
  - xvi) Only bonafide citizen of India will participate in the e-procurement and the bidder shall be debarred if he has been convicted of an offence under Rule-151 of GFR-2017 any bidder declared black listed/ bad performer by the Central/ State Govt./ Autonomous body and PSUs will also be debarred.
  - xvii) Suppliers will supply liquor as per actual requirement of respective unit / consignee.
  - xviii) In case of unavoidable circumstances i.e. any types of deceased, Consignee will right to stop any kinds of supply from suppliers at any stage.
  - xix) Line committee of the stores should be done by the respective units.
  - xx) If required, Price negotiation may be done by the competent authority as per provisions exists in GFR-2017.
  - xxi) Quality and quantity of the Liquor to be supplied by the suppliers to the respective unit should be best. Line Committee should receive the best quality of liquor after proper inspection. No compromise will be entertained on the issue at any cost.
  - xxii) If the price of a item or items are same of two or more than two firms, then L-I will be taken of the Firm based on maximum items are L-I out of these Firms.
  - xxiii) Details of rates, taxes, duties, discount, delivery period and other commercial conditions etc should be submitted on their letter pad.
  - xxiv) Rates must be clearly written in figures as well as in words.
  - xxv) There should not be any cutting/ over writing in the rates of the items.
  - xxvi) In the event of withdrawal or reduction in the number of troops and consequent reduction in demand, the contractor/ firm shall not be entitled to any compensation.

11. One sample of each brand of liquor for which firm is bidding will be deposited in Unit Hqr 166 Bn CRPF, New PCR Camp, Sidhra, Jammu (J&K) on or before 07/07/2018 at 1700 hrs.
12. All the samples must be marked as per S/No. given in BOQ.
13. Supply Order/demand of Liquor to successful bidder/firm will be placed by each Consignee.
14. **Payments:** Payment will be made to the successful bidder after acceptance & delivery of stores by each consignee.

**Note:-**

1. The firm while quoting rates must include packing, forwarding, bottling, insurance freight, and other charges if any.
2. As per terms and conditions of tender, firm may indicate their rate as per above code No. in BOQ. Firm may also indicate their rates /code no. on the bottle submitted as samples to this office.
3. Label specimen of each brand be attached with tender.
4. Important conditions/ instructions to tender be read carefully for strict compliance.
