**Note-3** : The maximum age limit for appointment on deputation shall be not exceed 56 years as on the closing date of receipt of the application.

The Armed Force personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. 


