OFFICE MEMORANDUM

Sub: **Implementation of the recommendations of the Seventh Central Pay Commission - Dress Allowance.**

Consequent upon the decision taken by the Government on the recommendations of the Seventh Central Pay Commission, vide Ministry of Finance's Resolution No.11-1/2016-IC dated 6th July 2017, in supersession of the existing orders relating to Uniform related Allowances viz. Uniform Grant, Kit Maintenance Allowance and Washing Allowance, which have been subsumed in a single Dress Allowance, the President is pleased to decide the rates of Dress Allowance in respect of personnel of Central Armed Police Forces (CAPFs), Assam Rifles and NSG, as under:-

Category of Employee	Rate per annum
Officers of CAPFs, AR & NSG	Rs.20,000/-
PBORs of CAPFs, AR & NSG	Rs.10,000/-

- The Allowances related to maintenance/washing of Uniform are subsumed in Dress Allowance and will not be payable separately.
- Further, categories of staff, who were earlier being provided Uniforms, will henceforth not be provided with Uniforms.
- The amount of Dress Allowance shall be credited to the salary of employee directly once a year in the month of July.
- This allowance covers only the basic uniform of the employee. Any special clothing, like that provided at high altitudes, will continue to be provided as per existing norms.
- The rates of Dress Allowance will go up by 25 percent each time Dearness Allowance rises by 50 percent.
- These orders shall be effective from 1st July, 2017.
- This issues as per MoF's OM No. 19051/1/2017-E.IV dated 02.08.2017, as vetted by IFD of this Ministry vide their Dy. No. CF-3396554/Fin.II/2017 dated 17.07.2017.
