- i. Three years experience as Trainer/Instructor in the rank of DySP/AC in planning, co-ordination, teaching and conduct of outdoor and indoor training related to field craft and tactics.
- ii. He /She should be qualified in minimum two certified courses conducted by the CAPF/State Police in areas like Map Reading & Tactics, Explosive weapons.
- iii. Two years service in operation field area in unit/battalion in the rank of DySP/AC/Inspector.
- iv. Working knowledge of computers.

- ii. Two years experience in the Works branch/section or possessing Bachelor Degree or Diploma in Civil./Electrical Engineering.
- iii. Having specialization in field craft and tactics.

- v. Officers below the age of 45 years will be preferred.
